JURIED MEMBER EXHIBITION

JUDGE: Neil Watson, Executive Director of the Katonah Museum of Art, Katonah, NY

ENTRY: Monday, July 26th, from 4pm to 8pm, Flinn Gallery, Greenwich Library, 2nd floor

ELIGIBILITY: Entrants must be Greenwich Art Society members. Members must pay current year dues if in arrears and new members may join on entry day. Works are not eligible if previously accepted for one of our juried exhibitions; if they have been exhibited in the GAS Gallery; or if completed prior to 2008. All submitted work must be appropriately framed, matted and presented. If a portrait, the price of a similar commission must be stated. No PORs.

CATEGORIES: All media welcome. However if you are planning an unusual installation or if equipment is required, you must receive permission from the Flinn Gallery. If meeting the Flinn's requirements, the artist will be required to install the equipment at entry for the judging and if accepted by the judge, install the piece on Wednesday July 28th from 1pm-3pm.

SIZE: Wall-hung works of any medium are limited to a 6' height and 5' width including frame. Works must be dry, sturdy, and wired securely for hanging. Alternate forms of presentation for wall-hung art are not discouraged but the method and appearance of the presentation must be integral to the piece and acceptable to the Flinn Gallery. Wall hung works not traditionally framed and wired may not exceed 15 pounds. Freestanding sculptures are limited to 8' in height mounted and to a 12' square (e.g. 3' x 4') floor area. Sculptors must provide bases if needed although temporary but secure bases are permitted for judging. The Flinn Gallery has the ability to show a limited number of small sculptures, books or other pieces that can be displayed in built-in cases. Works not meeting these requirements will not be judged.

ENTRY FEE: \$20 for one piece, \$15 for a second. Limit two.

PLEASE NOTE: ALL ENTRANTS, WHETHER ACCEPTED OR NOT, MUST TAKE A TURN AT THE RECEPTION DESK DURING THE SHOW. ENTERING YOUR WORK CONSTITUTES AGREEMENT TO THIS CONDITION. THE FLINN GALLERY REQUIRES ARTISTS NOT ABLE TO SIT TO FIND A REPLACEMENT OR HIRE A FLINN GALLERY SITTER TO TAKE THEIR PLACE.

AWARDS: Awards totaling at least \$2,000 will be presented at the opening reception. **JUDGING:** If your work is selected, you will be notified by phone no later than 3pm on Tuesday July 27th

REMOVAL OF WORK NOT SELECTED: If you do not receive a call, you must pick up your work Tuesday July 27th, between 4pm-8pm. The penalty of \$25 a day for each work picked up late will be enforced without exception.

REMOVAL OF SELECTED WORK: Monday, August 23rd, from 9am-11am. No early removals. Same penalty as for late pick-up.

LIABILITY: Although care will be taken, neither the Art Society nor the Greenwich Library will be responsible for loss or damage. Entry constitutes agreement to this condition.

SALES: Commission of 25% will be reserved from the price of each work sold as a result of this exhibition. Sales of displayed works within 3 months of the close of the exhibition will be subject to this charge.
